Form 990-EZ, Part I, Line 8 - Due to Covid restrictions, we were unable to produce a play that we had intended to produce. We were refunded the license fee for this play. We were also refunded other dues and fees to help with losses due to Covid.

Form 990-EZ, Part I, Line 16 - In 2020 we moved into a much bigger building in which we would produce plays. Most of the expense of line 16 (approx. \$100,000) involved the purchase and installation of items involved with turning the building into a playhouse, e.g., theatrical lighting, sound system, theater curtains, etc. The rest of the line 16 expense was simply the cost of producing plays, e.g., license, advertising, set building, etc.

Form 990-EZ, Part I, Line 20 - This change in net assets is due to our purchasing tangible property related to theatrical productions, e.g. lighting, sound system, curtains, etc. These real assets are shown on the balance sheet but not on the revenue or expense sections.

Form 990-EZ, Part II, Line 24 - These tangible assets are related to theatrical productions, e.g., props and costumes, lighting, sound system, curtains, etc.

Form 990-EZ, Part IV - Elections for President and Secretary were held in 2020 and new people were elected. In addition, a new office, Vice President of Community Affairs, was created and the former Vice President of Business took this position. Also, the Vice President of Arts stepped down. Thus, a new Vice President of Business and Vice President of Arts were also elected. This explains why President, Secretary, and Vice President of Arts is each listed for two different people.
